Recount of 'offer' from CF, pros and cons, previous experience of work and liaison with CF discussed. General feeling that this isn't a suitable option at this time. CF resources being stretched themselves is one major factor in not taking this forward at this time. Members present gave show of hands to discount this choice.

Remaining discussion continues around fulling exploring how the organisation could / would continue. History of LAVCH and benefits of the organisation revisited.

Current committee views – Sian happy to continue but with a refreshed committee. Teresa reviewing Constitution to clarify whether can continue as is no longer affiliated to a hall.

Keep alive, cut back in order to keep going. Specific examples of highlights of practice within LAVCH, anecdotes of 'good times' etc. conferred. Overall consensus optimistic about continuing. Show of hands given to confirm agreement to do so (unanimous = 5 member halls represented)

Acknowledgement of thanks given for participation in EGM. Summary of recommendation based on EGM outcome. To continue LAVCH, subject to nomination and acceptance of new Chair in the proceeding AGM. Form and function of LAVCH to be discussed at a future date.
